## Take this brochure to your supplier or prescribing clinician

Starting in 2026, new HCPCS (Healthcare Common Procedure Coding System) codes will be going into effect for hydrophilic catheters.

### What to do next

Bring this brochure to your supplier or prescribing clinician. They can update your prescription using the guidance listed below.



**Make sure** the prescription includes the word "hydrophilic" or brand name/item number. This update can be made at any time as it will work in 2025 and in 2026.

Even though the new code definition may sound different, the product you use isn't changing. The only change is the code a supplier must use when billing your insurance for hydrophilic catheters.

# Who's Involved in Your Care



**Prescribing Clinician**  
Prescribes your catheters.



**Insurance**  
Processes your claims for your catheters.



**Manufacturer**  
Makes your catheters, provides support and education, and may send samples\*.



**Supplier**  
Ships your catheters and bills your insurance.

## What is a HCPCS code?

HCPCS codes are the billing codes used on insurance claims to identify the medical product that was supplied.
